### **SELECTION PROCEDURE**

The selection procedure will be decided by NPCC depending upon the response received against the above post. The selection criteria can be by way of Personal Interview or by any other appropriate way. Decision of NPCC will be final in this regard. The final selection of the candidate will be based on the performance in the interview, or by any other appropriate way, whereafter the "Offer of Appointment" shall be issued. Selected candidate will be on probation for one year.

### **GENERAL**

- 1. Only Indian Nationals shall be eligible to apply.
- 2. All qualifications should be in full-time/part-time and regular/distance mode from any University / Institution recognized by UGC/AICTE or any Indian/foreign University/Institution which has been granted equivalence/recognition by AIU.
- 3. Fee, once paid, will not be refunded under any circumstances, nor would this fee be held in reserve for future selection. Candidates are therefore requested to verify their eligibility before paying the application fee.
- 4. Candidates are advised to give specific, correct and full information. All original certificates/documents in support of information furnished in the application form are to be produced at the time of interview, failing which the candidates will be disqualified for appearing in Interview. Candidature of the candidate is liable to be rejected at any stage of recruitment process or after recruitment or joining, if any information provided by the candidate is found to be false / fabricated or is not found in conformity with eligibility criteria mentioned in the advertisement.

- 5. Person with Bench mark Disability (PwBD) can also apply for the above post. Reservation against sub-quota for minority community will also be applicable as per Govt. guidelines against the post reserved for OBC (NCL).
- 6. Reservation of vacancies in respect of Economically weaker sections, Scheduled Castes, Scheduled Tribes, Other Backward Classes including minority (non-creamy layer), Ex-Servicemen, Persons with Benchmark Disabilities (degree of disability 40% or above) as per Govt. of India guidelines.
