TERMS & CONDITIONS OF APPOINTMENT ON DEPUTATION

- 1. The deputation will be initially for a period of three years effective from the date he is relieved from his duties in his parent department.
- 2. His deputation period can be extended upto maximum period of 5 years on year to year basis depending upon his performance and requirement of the Corporation with mutual consent and as per rule. No further extension beyond fifth year will be considered.
- 3. He may elect to draw either the pay in the scale of pay of this Corporation or his basic pay in the parent department plus deputation (duty) allowances plus personal pay, if any.
- 4. House rent allowance etc. as admissible under the rule of NPCC will be paid.
- 5. Travelling allowance as admissible to officers of his grade under the rule of NPCC.
- 6. Leave and pension contribution As per the lending department rule.
- 7. Medical facilities will be regulated in accordance with the rules of NPCC.
- 8. Dearness allowance As per option to draw the pay.
- 9. Allowed joining time and joining pay. TA/DA as per NPCC Rules.
- 10. Leave salary contribution and pension contribution / CPF (Employer's share) will be paid by NPCC while on deputation.
- 11. No provision exists for providing residential accommodation.
- 12. Personal pay, if any, drawn by him in his parent department will continue to be admissible on deputation if he opts to draw pay in the parent cadre scale/grade pay plus deputation (duty/allowance). No deputation (duty) allowance on this personal pay will however, be admissible.
- 13. Gratuity will be borne by NPCC during deputation period.
- 14. Increments: The employee will draw increment in the parent cadre grade or in the scale of pay / grade pay attached to the deputation post as the case may be.
- 15. Premature reversion of deputationist to parent cadre.
 - -Normally, when an employee is appointed on deputation/foreign service, his services are placed at the disposal of the parent department at the end of the tenure. However, as and when a situation arises for premature reversion to the parent cadre of the deputationist, his services could be so returned after giving an advance notice of at least three months to the lending department and the employee concerned.
